- 14. Allow taxpayers to examine assessment data.
- 15. During the first two hours, consideration of:
  - a. Waivers of the required 48-hour notice of intent to file an objection when there is good cause,
  - b. Requests for waiver of the BOR hearing allowing the property owner an appeal directly to the circuit court,
  - c. Requests to testify by telephone or submit a sworn written statement,
  - d. Subpoena requests, and
  - e. Act on any other legally allowed or required BOR matters.
- 16. Review Notices of Intent to File Objection.
- 17. Proceed to hear objections, if any and if proper notice/waivers given, unless scheduled for another date.
- 18. Consider/act on scheduling additional BOR Date(s).
- 19. Adjourn (to future date if necessary).
